(1) The Company's August 2021 results for Assets and Net New Assets included \$1.3 billion of brokerage assets from M&T Bank ("M&T"); July 2021 results included \$3.0 billion of brokerage assets from M&T; June 2021 results included \$15.6 billion of brokerage and advisory assets from M&T, of which \$3.1 billion was advisory assets and \$12.5 billion was brokerage assets, and \$0.7 billion of brokerage assets from BMO Harris Financial Advisors ("BMO"); May 2021 and April 2021 results included \$0.3 billion and \$2.1 billion, respectively, of brokerage assets from BMO; March 2021 results included \$11.8 billion of total brokerage and advisory assets from BMO, of which \$5.0 billion was advisory assets and \$6.8 billion was brokerage assets.

(2) Consists of total advisory assets under custody at the Company's broker-dealer subsidiary, LPL Financial LLC ("LPL Financial"). April 2021 and June 2021 results included \$32.6 billion and \$0.9 billion, respectively, of advisory assets related to the Company's acquisition of the wealth management business of Waddell & Reed Financial, Inc. ("Waddell & Reed"). November 2020 results included advisory assets related to the onboarding of E.K. Riley Investments, LLC ("E.K. Riley"). October 2020 results included advisory assets related to the onboarding of Lucia Securities, LLC ("Lucia Securities").

(3) Consists of brokerage assets serviced by advisors licensed with LPL Financial. April 2021 and June 2021 results included \$34.5 billion and \$0.9 billion, respectively, of brokerage assets related to Waddell & Reed. November 2020 results included brokerage assets related to the onboarding of E.K. Riley. October 2020 results included brokerage assets related to the onboarding of Lucia Securities.

(4) April 2021 Net New Assets included \$67.1 billion of assets related to the acquisition of Waddell & Reed. May, June, July, and August 2021 Net New Assets do not include subsequent results from Waddell & Reed advisors as the onboarding process is still ongoing.

(5) Consists of Advisory Asset Inflows minus Outflows plus Advisory Dividends plus Interest minus Advisory Fees.

(6) Consists of Brokerage Asset Inflows minus Outflows plus Brokerage Dividends plus Interest.

(7) Consists of net new assets excluding the acquisitions of Waddell & Reed, Lucia Securities and E.K. Riley. Acquired assets include \$1.8 billion of net new assets in June 2021 and \$67.1 billion of net new assets in April 2021 related to Waddell & Reed, \$2.5 billion of net new assets in November 2020 related to E.K. Riley, and \$1.5 billion of net new assets in October 2020 related to Lucia Securities.

(8) Consists of existing custodied assets that converted from brokerage to advisory, less existing custodied assets that converted from advisory to brokerage.

(9) In April 2021 and thereafter, results included \$1.1 billion of Money Market Account cash balances from Waddell & Reed.

(10) Represents the amount of securities purchased less the amount of securities sold in client accounts custodied with LPL Financial. Reported activity does not include any other cash activity, such as deposits, withdrawals, dividends received or fees paid.
